- 1 The letting will relate to the above dates only.
- 2 The letting fees must be paid at least 7 days before the rally is held and are not refundable.
- 3 The trading site will be occupied only by the trader, their agents and employees.
- 4 The trader must be on site and report to The Stallholder Marshal by 11.00am on the day of the rally and ready to trade by 12 noon.(If the trader has not arrived and reported to The Stallholder Marshal by 11.00am, the reservation cannot be guaranteed and maybe re-let .
- 5 Stalls must not be dismantled nor stock cleared away before 4.30pm and all trading must cease by 5.00pm
- 6 Vehicular access or movement will not be allowed on the site between the hours of 11.30am and 4.30pm.
- 7 On completion of business all refuse and litter generated by your trade must be picked up and removed from the site by yourself.
- 8 The site must be left in good order.
- 9 All business must be conducted in a clean, honest, civil and business like manner.
- 10 **No refreshments (food and drink of any description) are to be sold without prior consent of the organisers.**
- 11 No alcohol, live animals or fishes are to be sold or offered as prizes by any trader.
- 12 **No lotteries, competitions or cash collections (of any sort), for charities, other organisations or individuals are permitted at the event.** Charities may operate tombolas, and similar raffles offering instant prizes, from their stall only. (subject to appropriate approval under The Gambling Act [if necessary].
- 13 All business must be conducted from the allocated pitch. Stallholders are not permitted to roam the site selling or promoting their goods or services
- 14 The trader, their agents and employees will do nothing to adversely effect the health, safety and well being of either themselves, other traders or other persons attending the rally.
- 15 Nothing in these conditions is to be taken as relieving or excusing the trader, his agents or his employees, from any legal duty or responsibility.
- 16 the letting is subject to compliance with Calderdale Metropolitan Borough by-laws, rules and regulations in respect of markets and parks, and any other statues in force.
- 17 The trader must be in possession of suitable Public Liability insurance cover of not less than £1,000,000.
